### ***North American Landbird Conservation Plan Going Fast***

Over 7000 of the 10,000 copies of the PIF Continental Plan have been distributed and orders continue to roll in. As a reminder, boxes of plans have been distributed to: each USFWS regional office, each USFS regional office, the USFS Washington office, DOD-PIF, the National Park Service, the Canadian Wildlife Service, Bird Studies Canada, Point Reyes Bird Observatory, Rocky Mountain Bird Observatory, IAFWA, certain states (AZ, CO, ID, KY, NJ, NV, TX), Ducks Unlimited, the American Bird Conservancy, the National Audubon Society IBA program, the Playa Lakes and Sonoran JVs, Plum Creek Timber Company, and Weyerhaeuser Company.

We are sending 1-5 copies to any requester free of charge. But as we still need to recover some of the costs of publication, we are requesting donations of \$10 per plan for orders of more than 5 plans. ### ***Continental Objectives for States and BCRs***

At the request of IAFWA, Ken Rosenberg and the Cornell Lab of Ornithology has produced a guide for each state that steps down priorities and objectives found in the PIF North American Landbird Conservation Plan. The intent of each state report is to summarize the detailed information from PIF bird conservation plans that is most relevant to state planners and biologists as they develop their Comprehensive Wildlife Conservation Strategies. Each report has two parts—Part I is a user's guide that explains the standardized set of procedures and assumptions used to develop the data and information for each state. Part II has the actual data and information. The latter includes:

- priority species for each state, based on the PIF continental and physiographic area planning process;
- population estimates for each state, broken into portions of Bird Conservation Regions (BCRs) within each state;
- population objectives and numerical targets for each priority species, based on methods defined in the PIF North American Landbird Conservation Plan; and

a cross-referenced list of where relevant conservation issues, management recommendations, research and monitoring needs are found in the physiographic area and state PIF plans.—Debbie Hahn ([dhahn@sso.org](mailto:dhahn@sso.org))

### ***Coordinated Bird Monitoring***

The complex goal of establishing coordinated bird monitoring in North America continues to make progress on a number of fronts. Recently, the PIF Science Committee met to provide species-specific detail to meeting the long- and short-term monitoring needs for those landbird species identified in the Continental Plan as not adequately monitored. ### ***Species Assessment in Mexico***

All regional workshops for the assessment of the Mexican avifauna have now been completed. Mexican ornithologists will meet sometime this fall to reconcile possible differences in regional scores, and members of the PIF Science Committee will join them to discuss how the North American Landbird Conservation Plan will need to be adjusted to accommodate Mexican species and issues.—Eduardo E. ### ***Wetland Reserve Program Pilot***

PIF will be participating in a pilot project to develop guidance for the compatible use of Wetland Reserve Program (WRP) grasslands. The goal of the pilot will be to develop a separate table for each PIF physiographic area that provides guidance to managers regarding the compatibility of proposed activities in WRP

easements. Tables developed for each of the physiographic areas in the pilot area will contain the following three pieces of information: 1) list of bird species of greatest conservation interest in the region, 2) activities taking place on easements in the region (e.g., haying, grazing, mowing, food plots, timber harvest, etc.), and 3) responses by priority species to those activities. This is another step in the PIF goal of integrating landbird objectives into the programs of other partners. —Terry Rich

### ***Breeding Bird Survey Involvement Needed***

The BBS is the largest and longest running multi-species monitoring program for terrestrial species in North America. The value of BBS data is demonstrated by the continual outpouring of planning documents and peer-reviewed publications that use, not only BBS trend information, but also its relative abundance data. Despite the critical importance of this monitoring program, every year many BBS routes are not run. We have learned that even within resource agencies, certain offices may not support the participation of their capable, professional staff. As a result, Partners in Flight, the Patuxent Wildlife Research Center, and the American Bird Conservancy are developing an outreach strategy with the goal of seeing that all BBS routes are run every year. If you are a good birder (or supervise a good birder) who is not doing at least one BBS route every year, we need you!—Terry Rich

### ***Species Assessment Database Funding Sought***

Following strong endorsement by the Partners in Flight Council of the effort to secure permanent funding for the PIF Species Assessment Database, PIF has worked with the Rocky Mountain Bird Observatory and other partners to secure a grant from the National Fish and Wildlife Foundation for this work. This database has been the foundation for PIF Bird Conservation Plans, for the PIF North American Landbird Conservation Plan, has been an important source of information for the Birds of Conservation Concern list, and has been used by the National Audubon Society and American Bird Conservancy for their Watch List and Green List, respectively.

The basic need is to hire a full-time database manager who can keep up with the increasing flow of data and the increasing requests for information. The web site is currently getting 2000 hits per week and that will only go up as more information – global and step-down population estimates, for example – is added. Non-federal matching funds are sought.—Terry Rich

### ***Landbird Population Estimates Peer Review***

As a result of great interest in PIF's estimation of global population sizes for 448 species of landbirds, PIF held a peer-review workshop on 4-5 May 2004 in La Crosse, WI to examine methods for landbird population estimation. The

workshop was sponsored by USGS and included invited scientists from USGS, academia, U.S. Forest Service Research, Canadian Wildlife Service, and states. The review was very constructive. Products will include a set of recommendations to the PIF Science Committee and a pair of papers to be submitted for publication in a peer-reviewed conservation or ornithological journal.—Terry Rich

### ***NAWCA Technical Question 3***

The PIF Science Committee has been working with the North American Wetlands Conservation Council to produce maps to help address geographic priorities for wetland-associated landbirds. The current map follows the pattern of maps in the PIF Continental Plan by showing priorities by lat-long block. Weighting factors for each block include: 1) mean Area Importance score, 2) number of species on both the PIF Watch List and the NAWCA list for a given BCR, and 3) mean vulnerability score for species at that geographic location. The most critical piece of information in the system is the list of wetlands-associated species identified for each BCR. These lists and the best way to portray the multi-species value of a given site are being reviewed.—Terry Rich

### ***Neotropical Migratory Bird Conservation Act Awardees***

Congress appropriated \$4 million for the NMBCA for FY 2004. Following the 16 January 2004 deadline, the FWS received 139 proposals. Of these, 40 projects were selected for funding from the US and 20 countries from throughout the Western Hemisphere. These grants will conserve migratory bird habitat, further research and monitoring efforts, support law enforcement, and develop community outreach and education initiatives. The \$4 million in federal funds is being matched by \$16 million in partner funds. ### ***NAWCA Small Grants Program Makes Awards***

On 9 June 2004, the North American Wetlands Conservation Council reported to the Migratory Bird Conservation Commission, identifying 43 projects in 22 states and Puerto Rico that it had approved for funding under the North American Wetlands Conservation Act's Small Grants Program. Project partnerships received a total of \$1.9 million in grants to conserve nearly 12,000 acres of wetland and associated upland habitats. Partners' contributions to the projects amounted to more than \$11 million. ### ***Birders and the Federal Duck Stamp***

The USFWS has recently put up a new page on their site for the Federal Duck Stamp, a page addressed at concerned and responsible birders. It reiterates why birders should participate in the Stamp program, and it delivers the message - from their point of view - very well. As you may know, the official name of the Stamp is "The Migratory Bird Hunting and Conservation Stamp." It should be appreciated as such. Purchase of the Stamp, of course, supports the Refuge System and bird conservation. Remember, the Stamp is also a bargain, essentially a "\$15-annual pass" for all Federal refuges that charge an entrance fee. The new stamp became available in the first week of July, so this is a very good time to see what the USFWS is saying to birders on this subject.
